#### **Definitions**

#### General event information

#### 1. Opening times

The international trade fair VERTICAL PRO will take place from November 22nd to November 23rd, 2024, at the MFN exhibition grounds in Friedrichshafen. The exhibition is open on Friday from 9 a.m. to 6 p.m. and from 9 a.m. to 5 p.m. on Saturday. The right to alter the opening times due to serious reasons is reserved. Changes will be announced in good time. Access for exhibitors: 1 hours before start and 1 hour after end of the exhibition.

#### 2. Set-up and dismantling times

#### 2.1 Set-up:

November 20, 2024: 7:00 a.m. – 8:00 p.m. November 21, 2024: from 7:00 a.m. continuously

Advanced stand set-up must be approved by the project management and can be applied for via the OSC (subject to charge).

#### 2.2 Dismantling

November 23, 2024: from 5:00 p.m. (access for vehicles once permission is given)

November 24, 2024: 7:00 a.m. - 8:00 p.m. November 25, 2024: 7:00 a.m. - 4:00 p.m.

Early dismantling is not permitted. Before the start of the dismantling period, the exhibitor is not permitted to remove exhibits from the stand and/or to start dismantling the stand. In case of disregard, MFN reserves the right to claim damages (please note the MFN General Conditions of Participation).

#### 3. Registration and admission

Registration (participation and stand order placement) for the SCIENCE+ RESEARCH HUB for VERTICAL PRO 2024 is made by using the PDF registration form, which must be filled out and signed as legally binding. This registration is an offer of a contract, which requires acceptance by MFN. Submission of the registration form shall not constitute a claim for acceptance.

#### 8. Use of operations equipment
